BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:




- a. LGU-Bulalacao DAR-ARCP II loan proceeds
- b. LGU-Bulalacao DAR-ARCP II PBGS account


SEC. 2. This Special Ordinance shall take effect immediately.


