### ORDINANCE NO. 11-12-123

DESIGNATING THE OPEN SPACE BEFORE THE BAGSAKAN CENTER NEAR THE FISH LANDING PORT AREA, POBLACION, BULALACAO, ORIENTAL MINDORO AS FIRECRACKERS AND PYROTECHNIC ZONE

**SPONSOR:** Councilor Eduardo C. Aceron  
**CHAIRMAN:** Committee on Ordinances and Legal Matters

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** In order to promote safety among revelers during the celebration of the coming of the New Year and to regulate sell and use of firecrackers and pyrotechnic devices, the open space before the Bagsakan Center near the Fishlanding Port Area, Poblacion, this Municipality is hereby designated as Firecrackers and Pyrotechnic Zone;

**SEC. 2.** All barangays are likewise obliged to adopt their own Firecrackers and Pyrotechnic Zone in the pursuit of the above policy.

**SEC. 3. Penalty.** Any person violating this ordinance shall suffer the penalty of six (6) months imprisonment or shall be fined by an amount of One Thousand Pesos (Php1,000.00) but not to exceed Two Thousand Five Hundred Pesos (Php2,500.00) or both such fine and imprisonment at the discretion of the Court.


