ORDINANCE NO. 11 – 08 – 114

AN ORDINANCE IMPOSING PERMIT FEES FOR THE TRANSPORT OF SPECIFIC MERCHANDISE OUT OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Imposition of Fees. There is hereby levied the transport fees for specific merchandise out of the Municipality of Bulalacao, Province of Oriental Mindoro as follows:

a.	Bamboo per piece	-	Php 3.00
b.	Palm midribs per load	-	300.00
c.	Buri per load	-	300.00
d.	Salt per bag	-	1.00
e.	Onion/Garlic per load	-	400.00
f.	Copra per load	-	300.00
g.	Palay/Corn per load (6 wheeler)	-	250.00
	(10 wheeler)	-	300.00
h.	Melon per load	-	350.00
i.	Banana per load	-	350.00
j.	Seaweeds per sack	-	3.00
k.	Mango per kaing	-	5.00
l.	Watermelon per load	-	350.00
m.	Peanut per sack	-	5.00

SEC. 2. Time and Manner of Payment. The fees in the preceding section shall be paid to the Municipal Treasurer upon approval of the application. No business or trade undertaking can be lawfully began or pursued in this Municipality without the corresponding Mayors' Permit and the payment of the necessary fees imposed herein;

SEC. 3. Repealing Clause. All ordinances found to be inconsistent with this Ordinance are hereby repealed or modified accordingly.


SEC. 4. Penalty. Any violation of this ordinance shall be punished by a fine of not less than One Thousand Pesos (Php1,000.00) but not more than Two Thousand Five Hundred Pesos (Php2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both such fine and an imprisonment at the discretion of the Court;


SEC. 5. Effectivity. This Ordinance shall take effect ten (10) days after its posting.




