SPECIAL ORDINANCE NO. 16-10-49

SPECIAL ORDINANCE CREATING THE MISS BULALACAO SEARCH COMMITTEE, PRESCRIBING ITS FUNCTIONS AMONG OTHER PURPOSES

SPONSOR: SB MEMBER DEXTER R. GONZALES
CHAIRMAN: Committee on Tourism, Trade, Commerce and Industry
CO-SPONSOR: SB MEMBER GERMAN S. ACOSTA

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. TITLE. This Ordinance shall be known as “**Special Ordinance Creating the Miss Bulalacao Search Committee, Prescribing its Functions, Among Other Purposes**”.

SEC. 2. CREATION. There is hereby created Miss Bulalacao Search Committee (MBSC) in the Local Government Unit of Bulalacao, Oriental Mindoro, hereinafter referred to also as the Committee.

SEC. 3. FUNCTIONS. The MBSC shall perform with utmost impartiality and diligence the following functions:

- a. Formulate internal policies that would govern the effective and efficient performance of functions stated herein;

- b. Deliberate and recommend to the Sangguniang Bayan the granting of franchise to any qualified foundation or non-government organization having the credibility, capability, resources and linkages to perform the following functions, provided that in the absence of such foundation or non-government organization, the Committee shall have to perform the applicable and practical functions;
 - b.i. Formulate annual plan of action in order to organize activities and projects in relation with the annual Search for Miss Bulalacao;
 - b.2. Implement or coordinate for the implementation of such plan in conformity with related policies, laws and ordinances like, but not limited to, prohibition on exploitation and discrimination of minors, indigenous people, vulnerable individuals and women in general;
 - b.3. Develop recruitment, screening, qualifying, orientation, judging and pageant criteria, policies or procedures in accordance with those set forth and observed by the Miss Oriental Mindoro Charities Incorporated (MOMCI);
 - b.4. Decide on protests, answer inquiries and give pronouncements as maybe necessary in order to protect the integrity of the pageant;
 - b.5. Train, guide, assist and send the officially declared Miss Bulalacao in representing the Municipality to the annual Search for Miss Oriental Mindoro;
 - b.6. Uphold integrity, fairness, morals and transparency in all pageant activities at all times;
 - b.7. Promote the enterprises and products, tourism sites and activities and culture and tradition of Bulalacao and the use of indigenous, recyclable and biodegradable materials in all pageant undertaking;
 - b.8. Discover, develop, promote, recognize and reward local talents and skills of this Municipality;
 - b.9. Assist Sangguniang Barangays in holding pageants that will help search for candidates to Search for Miss Bulalacao;
 - b.10. Raise, manage and protect funds through just and legal means in order to support its charitable works to be actively participated by candidates and supporters; and
 - b.11. Recommend to the local chief executive or to the Sangguniang Bayan necessary adjustments, policies, ordinances or resolutions like regulation on holding pageants and personality search other than the Search for Miss Bulalacao;

- c. Certify for the actual participation of the chosen candidate representing the Municipality of Bulalacao, Oriental Mindoro to the annual Search for Miss Bulalacao to support the candidate's claim for financial incentive amounting Fifteen Thousand Pesos (PhP15,000.00);
- d. Conduct meetings, conferences, caucuses, or consultation activities in connection with the functions cited herein;
- e. Perform other functions that the Committee may deem important in line with the spirit and intent of this Ordinance; and
- f. Recommend to appropriate authority necessary adjustments, mechanisms and measures related to this concern.

SEC. 4. ORGANIZATIONAL STRUCTURE. The MBSC shall have organizational structure composed of the following:

Chairperson - Municipal Mayor or duly authorized representative

Members - Tourism Officer

President or representative of an association of talent scouts/make-up artist/other pageant enthusiasts

President or representative of religious sector or of an association with advocacy on women or gender and development

SB Chairperson of the Committee on Tourism

President, Liga ng mga Barangay

President, Municipal Tourism Council


Members shall elect from among themselves the Assistant Chairperson and Secretary of the Committee.

SEC.5. BUDGET. Expenses that may be incurred in relation with the operation and performance of the Committee shall be chargeable against the appropriate allotment in the maintenance and other operating expenses of the Office of the Municipal Mayor. This shall be considered in the annual appropriation for the concerned office. Allocation for the conduct of Miss Bulalacao Pageant or subsidy to the foundation or organization granted with the franchise shall be provided with adequate appropriation in the annual budget of the Local Government Unit of Bulalacao, Oriental Mindoro.

SEC. 6. EFFECTIVITY. This Special Ordinance shall take effect immediately upon its approval. A copy of the approved Special Ordinance shall be given to each member and to all stakeholders mentioned herein and shall be posted on bulletin boards of the Local Government Unit of Bulalacao.


