SPECIAL ORDINANCE NO. 16-09-47

SPECIAL ORDINANCE GRANTING MONTHLY ALLOWANCE TO THE PRESIDING JUDGE OF THE REGIONAL TRIAL COURT BRANCH NO. 43 LOCATED IN ROXAS, ORIENTAL MINDORO AND APPROPRIATING FUNDS THEREFOR

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. STATEMENT OF POLICY. It is the policy of the Local Government Unit of Bulalacao, Oriental Mindoro to support the speedy and effective justice system as it strongly believes that justice delayed is justice denied. The Sangguniang Bayan of Bulalacao is tasked by the Local Government Code of 1991, when the finances of the municipal government allow, to provide for additional allowances and benefits to judges, prosecutors, public elementary and high school teachers and other national government officials stationed in or assigned to the Municipality.

SEC. 2. ENTITLEMENT. The Presiding Judge of the Regional Trial Court Branch No. 43 shall be granted allowance not exceeding Ten Thousand Pesos (PhP10,000.00) every month;

Incumbent of the herein mentioned position who shall incur unauthorized absences or who shall be on leave of absence for at least ten (10) calendar days shall not receive this benefit proportionate to the number of days absent. The Acting Officer or In-Charge of office shall instead become the recipient until the return to office of the concerned officials.

The initial disbursement of this allowance shall be allowed only upon submission of the requirements mentioned in Section 3.


SEC. 3. REQUIREMENTS. Submission of the following requirements shall be required prior to the granting of allowance:

- a. Request letter
- b. Appointment letter
- c. Monthly accomplishment report

SEC. 4. FUND. There shall be annual allocation for this allowance in the Office of the Municipal Mayor under Legal Services budget and accounting code in maintenance and other operating expenses.

SEC. 5. EFFECTIVITY. Unless otherwise stated hereto, all other provisions of this Ordinance shall take effect immediately.






