**ORDINANCE NO. 16-08-166**

**AN ORDINANCE SUBMITTING ALL MUNICIPAL OFFICIALS AND EMPLOYEES OF THE LOCAL GOVERNMENT UNIT OF BULALACAO, ORIENTAL MINDORO TO A DRUG TEST ONCE EVERY YEAR**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1. STATEMENT OF POLICY.** It is a policy of the Local Government Unit of Bulalacao, Oriental Mindoro to promote transparency, accountability, efficiency, honesty and responsibility among its officials and employees as it affirms its commitment to uphold and respect Republic Act No. 9165 or Comprehensive Dangerous Drugs Act of 2002 and Civil Service Laws and Rules.

**SEC. 2. DRUG TEST.** All officials and employees of the Local Government Unit of Bulalacao, Oriental Mindoro shall undergo an unannounced annual random drug testing which is to be done by any government forensic laboratories or by any of the drug testing laboratories accredited and monitored by the Department of Health (DOH) to safeguard the quality of test results. The Office of the Municipal Mayor or his/her with assistance from the Municipal Health Office shall render necessary service during the procedure. Coordination with the duly chosen accredited laboratory prior to the test shall be made by the Office of the Municipal Mayor thru the highest ranking HRMO.

**SEC. 3. PENALTY.** Any officer or employee found positive for use of dangerous drugs, or who fail to submit himself/herself to the drug test, shall be administratively dealt with and such shall be a ground for suspension or dismissal subject to the pertinent provisions of the Civil Service Laws and Rules.

**SEC. 4. FUND.** There shall be annual allocation for this purpose under the Office of the Municipal Mayor.


**SEC. 5. REPEALING CLAUSE.** Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

**SEC. 6. EFFECTIVITY.** This Ordinance shall take effect immediately

**ENACTED** this 2<sup>nd</sup> day of September, 2016, Bulalacao, Oriental Mindoro.


