**SPECIAL ORDINANCE NO. 17-10-13**

**SPECIAL ORDINANCE PRESCRIBING POLICIES ON ADOPTING NON-BULALACAONONS AS AN ADOPTED SON OR DAUGHTER OF BULALACAO, ORIENTAL MINDORO**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The following guidelines shall be adopted:

- A. A non-Bulalacaonon person may be adopted as a son or daughter thru a Sangguniang Bayan resolution only upon written nomination by any registered resident of this municipality;
- B. The nomination which states significant accomplishments and reasons why the nominee should be adopted, shall be addressed to the Local Chief Executive (LCE) who shall make favourable recommendation to the Sangguniang Bayan after conducting initial assessment on merits of the nomination;

C. No resolution adopting a non-Bulalacaonon shall be approved without the said recommendation from the LCE.

**SEC. 2.** A non-Bulalacaonon individual shall be adopted only upon meeting the following qualifications:

- A. Must have stayed in or have rendered services to this municipality for at least one (1) year;
- B. Must be a person of good moral character and a law-abiding citizen;
- C. Must possess legal documents of stay or applicable visa, if alien;
- D. Must be familiar with the way of living, culture, and tradition of the municipality; and
- E. Must have participated in or initiated at least five (5) community development activities.

**SEC. 3.** The following documentary requirements shall be required by the Sangguniang Bayan prior to the approval of the resolution:

- A. Nomination paper duly signed by nominator and conformed with by the nominee;
- B. Recommendation letter addressed to the Sangguniang Bayan duly signed by the LCE;
- C. Certification signed by the concerned Punong Barangay regarding the length of stay or record of service in the municipality, being a person of good moral character, and familiarity with the municipality's way of living, culture, and tradition;
- D. Certification of no pending case issued by the Chief of the Municipal Police Station;
- E. Certified true copy of visa or any legal document of stay, for aliens;
- F. Certification/s pertaining to at least five (5) community development activities participated in or initiated by the nominee;
- G. Most recent personal data sheet and personal narration by the nominee of his/her pertinent accomplishments and of his/her insights on being an adopted son or daughter of Bulalacao; and
- H. 1 piece 10R colored photo

**SEC. 4.** The adopted son and daughter shall be conferred with certificate of adoption signed by the LCE, approved Sangguniang Bayan resolution of adoption, one-time cash award of PhP 10,000.00, and 3-day free town tour with free board and lodging for the adoptee & any 2 immediate relatives.

All rights and privileges accorded to a Bulalacaonon by the government or private sector shall be likewise accorded to the adoptee.

**SEC. 5.** The adoption shall be revoked anytime should the adoptee commit any violation of law and exhibit conduct unbecoming of a responsible person as reported by any barangay official.

**SEC. 6.** Any official, officer, employee, or worker who disregards or neglects or cause to disregard or neglect the implementation of this Ordinance shall be administratively dealt with and such shall be a ground for suspension or dismissal or termination subject to the pertinent provisions of the Civil Service Laws and Rules and other applicable laws and policies.

**SEC. 7.** Any Ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.



**SEC. 8.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.


**SEC. 9.** This Ordinance shall take effect immediately fifteen (15) days after posting of approved ordinance in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.






