MUNICIPAL ORDINANCE NO. 19-12-251

AN ORDINANCE CREATING THE MUNICIPAL ENVIRONMENT AND NATURAL RESOURCES COUNCIL OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

SECTION 1. This ordinance shall be known as "An ordinance creating the Environment and Natural Resources Council"

SECTION 2. COMPOSITION

- h. **Municipal Environment and Natural Resources Officer (MENRO)**- refers to the LGU employee who may be appointed or designated by the concerned Local Chief Executive (LCE) and who shall be directly responsible for the planning and implementation of the devolved DENR functions to the LGU's pursuant to section 484 of the Code.
- i. **Environmental Compliance Certificate (ECC)**- refers to license/ permit/authorization which DENR issued in favor of project proponent of which have been reviewed, evaluated and finally approved by the DENR pursuant to P.D. 1586 as well as Proclamation No. 2146 otherwise known as Environment Impact Assessment System (EIAS).
- j. **Foreign- Assisted Projects**- refers to DENR projects which are wholly and/or partially funded from foreign sources.
- k. **Lot Surveys**- refers to the survey of specific lots particularly private lands.

SECTION 5. FUNCTIONS.

- a. To formulate the Environment Code of the Municipality of Bulalacao and submit to the Sangguniang Bayan for approval.
- b. It shall endeavour to establish, protect and maintain tree parks, green belts, mangroves similar forest developmental projects and other tourist attraction.
- c. It shall recommend to the Sangguniang Bayan to legislate the imposition of appropriate penalties for acts which endanger the environment such as dynamite fishing and other forms of destructive fishing, illegal extraction and transport of forest products and endangered flora and fauna and commission of other as penalized under P.D. 705 as amended by Executive Order No. 277 series of 1987.
- d. It shall recommend to the Sangguniang Bayan to legislate measures for the enhancement and protection of Local Water Supply.
- e. To recommend the enforcement of pollution control and environmental protection of laws, rules and regulations.
- f. To recommend the issuance of Environmental Compliance Certificate for the projects.
- g. To recommend apprehension and testing of smoke belching vehicles and the collection of appropriate fees and charges.
- h. To recommend the implementation of a solid waste disposal and other environmental management system and service related to general hygiene and sanitation such as sewerage and household waste disposal.
- i. To recommend rules and regulations for the abatement of noise and other form of nuisance as defined by law.
- j. To recommend the enforcement of mining laws subject to the policies of the Local Government.

- k. To recommend the conduct of cadastral and lot surveys.
- l. To recommend the cancelation of Mayor's Permit to any establishment that habitually violates environmental laws, rules, regulation and policies of the Local Government.
- m. To monitor foreign assisted projects which are wholly or partially funded from foreign sources.
- n. To recommend the formation of a Pollution and Adjudication Board to be chaired by the Mayor, MENRO or the government lawyer with a minimum experience of 5 years in the practice of law.
- o. To recommend the implementation of a cease and desist order issued by the Pollution and Adjudication Board.
- p. To recommend to the Sangguniang Bayan the enactment of ordinances on all matters relative to the protection conservation maximum utilization, appreciation of appropriate technology enhancement and other matters related to the environment and natural resources.
- q. To solicit funding from multi-lateral nongovernment organization foundations and other agencies to augment its finances for its operation.

SECTION 6. FUNDING. Initially the Municipality of Bulalacao shall appropriate One Hundred Thousand pesos (PhP100,000.00) for calendar year 2020, and shall appropriate funds for the succeeding years for its yearly operations.

SECTION 7. PROGRAM. All programs, policies, rules and regulation, approved by the council shall be subjected to the approval of the Local Chief Executive (LCE) and by the Sangguniang Bayan.

SECTION 8. SEPARABILITY CLAUSE. Any provisions or portions of this ordinance found to be violated of the constitution or invalid shall not impair the other provision or parts thereof which shall continue to be in force and in effect.


SECTION 9. REPEALING CLAUSE. Ordinances, rules and regulations or parts thereof which are inconsistent or in conflict with provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 10. EFFECTIVITY. This Ordinance shall take effect immediately after fifteen (15) days of posting in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.




