SANCTUARY"

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao,
Oriental Mindoro:

SECTION 1. The site and coverage of the established Maasin
Fish Sanctuary is hereby amended pursuant to Kapasiyahan Blg. 18-
2019 of Barangay Maasin entitled "Kapasiyahan na naglalayong
magtatag muli ng karagdagang sukat na ang dating sukat na 18.7
hectares ay gagawing 40 hectares palaot bilang kabuuang sukat ng
Marine Protected Area" dated October 28, 2019 to widen the area for
protection and conservation of fisheries and aquatic resources in
Barangay Maasin.

SEC. 2. Section 2 of Ordinance No. 15-02-144 entitled "An Ordinance Establishing the Maasin Fish Sanctuary" is hereby amended to be read as follows, to wit:

"SEC. 2. Site and Coverage. The Maasin Fish Sanctuary is that body of waters consisting of some forty (40) hectares, situated in the northwest of Maasin Island enclosed by imaginary straight lines drawn and connecting the following points:






