MUNICIPAL ORDINANCE NO. 20-02-257

AN ORDINANCE DESIGNATING GUILLERMO H. SALAS, SR. MEMORIAL GYMNASIUM SITUATED IN BARANGAY POBLACION, BULALACAO, ORIENTAL MINDORO AS TEMPORARY PARKING AREA

WHEREAS, Section 447 of the Local Government Code of 1991 clearly states that among the powers, duties, and functions of the Sangguniang Bayan is to regulate the use of streets, avenues, alleys, sidewalks, bridges, parks, and other public places and to approve the construction, improvement, repair and maintenance of the same; to establish bus and vehicle stops and terminals or to regulate the use of the same by privately-owned vehicles which serve the public; to regulate garages and the operation of conveyances for hire; to designate stands to be occupied by public vehicles when not in use; to regulate the putting up of signs, signposts, awnings, and awning posts on the streets; and to provide for the lighting, cleaning and sprinkling of streets and public places;

WHEREAS, the same Section of the said Code further states that the Sangguniang Bayan shall regulate traffic on all streets and bridges, prohibit the putting up of encroachments or obstacles thereon, and, when necessary in the interest of public welfare, authorize the removal of encroachments and illegal constructions in public places;

**WHEREAS**, in adherence to the directive of President Rodrigo Roa Duterte, the Department of Interior and Local Government issued Memorandum Circular No. 2019-121 dated 29 July 2019 and DILG M.C. No. 2019-167 dated 4 October 2019 which mandate all Provincial Governors, City and Municipal Mayors, Punong Barangays including Local Engineering Department Heads to clear roads of illegal structures/obstructions and to reclaim all public roads that are being used for private ends;

**WHEREAS**, because there is no identified public parking and park-for-fee spaces in Barangay Poblacion, public utility and private vehicles have been using roads and sidewalks along A. Salas St. and Contreras St. in front of the municipal building, posing dangers to riding public and pedestrians;

**WHEREAS**, while the Local Government Unit of Bulalacao and the Sangguniang Barangay of Poblacion shall have to assign or construct public parking areas yet, there is a need to designate temporary parking space to comply with related laws, directives, and issuances in order to ensure public order, safety and convenience.

**NOW THEREFORE**, be it ordained by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

**Section 1.** The municipal gymnasium situated in Barangay Poblacion, Bulalacao, Oriental Mindoro is hereby designated as temporary parking area from 6:00 AM to 6:00 PM daily.

**Section 2.** The holding of any other activity which shall need the use of municipal gymnasium shall be given priority provided such activity shall have secured necessary permit from the Office of the Municipal Mayor and shall have paid the corresponding fee/s to the Municipal Treasury Office if applicable. In such case, the Office of the Municipal Mayor shall designate alternative parking spaces taking into consideration DILG Memorandum Circulars No. 2019-121 dated 29 July 2019 and No. 2019-167 dated 4 October 2019. Notices pertaining to alternative parking spaces shall be conspicuously posted outside gymnasium.

**Section 3.** The Municipal Mayor shall assign a gymnasium administrator who shall take charge on the daily operation, give instructions on schedule of activities and maintenance routines, and perform other functions that the Municipal Mayor shall so order. The gymnasium administrator shall also assign certain space for different kind of vehicles and shall reserve areas for municipal officials and heads of office.



**Section 4.** The fund needed for the implementation of this Ordinance shall be charged against the related accounts under the Maintenance and Other Operating Expenses of the Office of the Municipal Mayor for the current year and for years thereafter.



Disbursement shall only be allowed upon presentation of necessary documents as may be required by the Municipal Accounting Office.

**Section 5.** Any officer, employee, or worker of the LGU of Bulalacao who shall disregard or neglect the implementation of this Ordinance shall be administratively dealt with and such shall be a ground for suspension or dismissal subject to pertinent provisions of the Civil Service laws and rules and applicable policies.

**Section 6.** The violation of this Ordinance shall be penalized in accordance with existing national laws and municipal ordinances pertaining to traffic and illegal parking.




**Section 7.** Any ordinance inconsistent with the provisions of this Ordinance is hereby repealed or modified accordingly.

**Section 8.** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect. Higher laws or policies inconsistent with the provisions of this Ordinance shall prevail.

**Section 9.** This Ordinance shall take effect immediately until revoked by means of another ordinance and shall be posted in bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Local Government Unit of Bulalacao.






