"WHEREAS, for over the past decades, our Government has always been prioritizing the rural electrification, it strongly believes that the provision of electric services will produce more opportunities to improve the socio-economic growth of the marginalized sectors, and it will have a greater access to basic services and better infrastructure for rural development;

"WHEREAS, the Oriental Mindoro Electric Cooperative, Inc. (ORMECO) is an electric distribution cooperative that concentrates in giving power distribution and efficient consumer services for the entire Province of Oriental Mindoro, also throughout the decades it maintained the Category A Large level status based on the extent and volume of operations as compared with other electric cooperative in the country;

"WHEREAS, Bulalacao is a third class municipality located at the southernmost tip of the Province of Oriental Mindoro, it has a Municipal Government that aims to establish an efficient local organization which is responsive to the needs of the locality and effectively manages its resources to sustain growth and development;


"WHEREAS, the ORMECO Roxas office is the nearest office to Bulalacao, it is a 43.6 km distance and could cost PhP150 for a one-way commute that burdens the residents of Bulalacao in paying electric bills and transacting other concerns to the office;


"WHEREAS, being the farthest town, Bulalacao has always been at disadvantage in getting adequate service from ORMECO, thus, this Sanggunian is humbly requesting to put up an extension office of ORMECO in this municipality that would positively provide convenience to its consumers; Now, therefore, be it...
