**AN ORDINANCE GRANTING ADDITIONAL COMMUNICATION ALLOWANCE TO MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT UNIT (MDRRMU) IN THE AMOUNT OF TWO THOUSAND PESOS (Php2,000.00) EVERY MONTH**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1. STATEMENT OF POLICY.** It is the policy of the Local Government Unit of Bulalacao, Oriental Mindoro (LGU of Bulalacao) to maintain empowered, high morale, and productive workforce. The Sangguniang Bayan of Bulalacao is tasked by the Local Government Code of 1991 to determine salaries, wages, allowances, and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds.

**SECTION 2. COMMUNICATION ALLOWANCE.** The Municipal Disaster Risk Reduction Management Unit (MDRRMU) is hereby granted an additional communication allowance in the amount of two thousand pesos (Php2,000.00) every month to be used for the conduct of its personnel's duties and functions specifically when they are doing tasks related to COVID 19 pandemic detailed in Milagrosa-Magsaysay Boundary and the Bulalacao Roro Port.

**SECTION 3. CONDITION OF THE GRANT.** This grant shall be given within the COVID 19 pandemic period only and shall be subject to usual budgeting, accounting, and auditing law, rules and regulations.

**SECTION 4. APPROPRIATION.** The fund shall be sourced from Maintenance and Other Operating Expenditures (MOOE) of the Office of the Municipal Administrator for the current year and years thereafter.

**SECTION 5. REPEALING CLAUSE.** All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

**SECTION 6. EFFECTIVITY.** This Ordinance shall take effect on February 1, 2021.
