**AMENDING SECTION 3M.01, ARTICLE M OF THE 2004 NEW REVENUE  
CODE OF BULALACAO, ORIENTAL MINDORO, PERMIT FEE ON  
STORAGE OF FLAMMABLE, COMBUSTIBLE OR EXPLOSIVE  
SUBSTANCES**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** Section 3M.01, Article M of the 2004 New Revenue Code of Bulalacao, Oriental Mindoro, Permit Fee on Storage of Flammable, Combustible or Explosive Substances is hereby amended to read as follows:


**“Section 3M.01. Imposition of Fee. There shall be collected from every person storing flammable, combustibile or explosive substances the following permit fees:**




- a) Storage of gasoline, naphtha, diesel, fuel and similar products
  - Less than 5,000 liters - PhP1,500 per annum
  - 5,000 to 10,000 liters - 2,500 per annum
  - 10,001 to 15,000 liters - 5,000 per annum
  
- b) Storage of other flammable, combustible or explosive substances
  - Less than 1,000 kilograms - PhP1,000 per annum
  - More than 1,000 kilograms - 1,500 per annum"


**Section 2.** This ordinance shall take effect upon approval.


