MUNICIPAL ORDINANCE NO. 23-07-359

**AN ORDINANCE ESTABLISHING THE CENTENARIAN AWARD TO
QUALIFIED CITIZENS IN BULALACAO, ORIENTAL MINDORO AND
PROVIDING BENEFITS AND FUNDS THEREOF**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in session assembled that:

SECTION 1. TITLE. This Ordinance shall be known as
"ESTABLISHING CENTENARIAN AWARD TO QUALIFIED CITIZENS IN
BULALACAO, ORIENTAL MINDORO AND PROVIDING BENEFITS AND
FUNDS THEREOF".

SECTION 2. OBJECTIVES. The purposes for which this Ordinance is
being enacted are the following:

- d. Burial assistance of PhP15,000.00 upon the demise of the centenarian;
- e. Christmas Gift of PhP5,000.00 from the Municipality of Bulalacao.

Further, whenever the "Centenarian Citizen" will still enjoy the succeeding year/s he/she may be granted such benefits, to wit:

- i. Cash Gift of P20,000.00 from the Municipality of Bulalacao on his/her birthday;
- ii. Birthday Cake;
- iii. Christmas Gift of PhP5,000.00 from the Municipality of Bulalacao.
- f. In case the awardee die on the day of his birthday, the authorized representative will receive the benefits.

SECTION 6. QUALIFICATIONS. To avail the Benefits and Privileges provided in Section 5 of this Ordinance, the following qualifications should be met:

- a. He/She must be a Filipino citizen;
- b. Must be a permanent resident of the Municipality of Bulalacao for at least six (6) years up to the recognition; and
- c. Must be at least 100 years old.

SECTION 7. REQUIREMENTS. Identification documents must be complied and submitted to the Municipal Social Welfare and Development Officer (MSWDO) to prove the centenarian's age, are the following:

- a. Senior Citizens' Identification Card issued by the Office of the Senior Citizens Affairs (OSCA) and Federation of Senior Citizens in the Municipality where the centenarian resides; and/or
- b. Birth Certificate and/or in the absence thereof, other valid documents which shows the awardee's age or birthdate, shall include but not be limited to the following: Baptismal Certificate, Marriage Contract, Driver's License, Voters ID, SSS/GSIS ID, PRC card, or postal ID or any identification that shall provide date of birth.

SECTION 8. CENTENARIAN RECOGNITION CEREMONY. The Centenarian Award shall be conferred to the centenarian awardee/s to be given by the Municipality of Bulalacao Officials in a fitting ceremony. The Centenarian Awardee should be personally present to receive the award, except if he or she is an invalid, bedridden, or in any other manner physically incapable of attending the recognition ceremony, the Awarding Committee will go to his/her residence or hospital where he/she is confined to give the award.

SECTION 9. EVALUATION COMMITTEE. The following government agencies will be responsible for the evaluation process of the centenarian awardees. The Office of the Municipal Social Welfare and Development (MSWD) as the Lead Government Agency.











Member agencies:

- Office of the Municipal Civil Registrar.


SECTION 10. Separability Clause- If any provision of this Ordinance is held invalid, other provisions which are not affected shall remain in full force and effect.

SECTION 11. Effectivity. This Ordinance shall take effect upon approval.


