**AN ORDINANCE CREATING A LOCAL DRINKING WATER QUALITY
MONITORING COMMITTEE IN THE MUNICIPALITY OF BULALACAO,
PROVINCE OF ORIENTAL MINDORO**

WHEREAS, the Presidential Decree 856 known as the Code on Sanitation aims to improve the way of life of Filipinos by directing, public health services towards the protection and promotion of the health of our people.

WHEREAS, the Municipality of Bulalacao should create a Local Drinking Water Quality Monitoring Committee to ensure that the supply of drinking water in Bulalacao, Oriental Mindoro is safe and fit for human consumption;

- vi. Inform the public of the latest quality of the drinking water in the locality;
- vii. Endorse the annual work and financial plan on water quality surveillance program;
- viii. Review approve location of water sampling;
- ix. Conduct regular quarterly meeting or as the need arises;
- x. Perform other functions related to water quality assurances;
- xi. Ensure the continuous supply of potable drinking water supply in every household and
- xii. To accept complaints for lack of water supply and potability of local drinking water.

SECTION 4. Responsibilities of the members of Bulalacao Drinking Water Quality Monitoring Committee.

A. Responsibilities of the Chairperson:

- 1. Act as chairperson of the committee;
- 2. Certify the passing of an ordinance consistent with the supplemental implementing rules and regulations pertaining to water supply;
- 3. Provide necessary funds for suppliant and materials to the rural health unit department for the enforcement of these supplemental implementing rules and regulations;
- 4. Issue directives upon the recommendation of the Municipal Health Officer for the closure of establishments operating without the necessary sanitary permit and/or whose operation is inconsistent to the DOH standards and these rules and regulation;
- 5. Prohibit the selling of water purifiers or equivalent apportion if found to be not confirming to the DOH standards;
- 6. Enforce the pertinent provisions of Chapter 2 water supply of P.D 856.

B. Responsibilities of Municipal Health Officer. The Municipal Health Officer shall:

- 1. Take the overall lead in the implementation of drinking water quality surveillance program;
- 2. Ensure inter sectoral linkages in the drinking water quality program;
- 3. Conduct or cause the conduct of sanitary inspection and evaluation of every Barangay works system and refilling station and validates the water quality of each establishment;

4. Issue sanitary permit to establishment which are found to be complying with the minimum sanitary requirements;
5. Issue health certificate to all personnel including drivers of delivery vehicles of the establishments;
6. Issue certification of potability of drinking water in accordance with Chapter 2 water supply supplement IRR;
7. Cause the conduct of sanitary survey for the development of drinking water supply source and recommend to the municipal mayor, the issuance of drinking water site clearance to applicants;
8. Validate from the Department of Health (DOH) of water purification apparatus devices and similar gadgets being sold or peddled to the public;
9. Cause the conduct of the investigation of any claim on advertise water product or water purification equipment which in his/her judgement maybe detrimental to public health and safety;
10. Perform other related tasks.

C. Responsibilities of Water Provider he/she shall:

1. Provide update on water monitoring plan and its implementation;
2. Provide technical and logistics assistance to the committee;
3. Pay the sanitation and inspection fee and other applicable fees on conduct on their business;
4. Submit quarterly reports to the Municipal Health Officer of water analysis results issued by accredited license testing officer;
5. Secure the Certificate of Potability of drinking water at frequencies prescribed in the rules and regulations;
6. Submit results of laboratory analysis of treated water passing purifier.

D. Responsibilities of the Chairperson on Health and Sanitation, Chairperson on Environment and Forestry, Chairperson on Ordinances and Legal Matter and Chairperson on Barangay Affairs shall:

1. Introduce appropriate resolutions/ordinances concerning drinking water quality surveillance;
2. Provide information to the committee associate existing resolution that may affect water quality surveillance;
3. Endorse the work and financial plan prepared by the committee for corresponding budget appropriation by the Sangguniang Bayan.

E. Responsibilities of the Municipal Engineer. The Municipal Engineer shall:


1. Inform the committee on relevant civil work in the area that may affect the quality of water sources;
2. Provide technical and logistic assistance to the committee.


SECTION 7. REPEALING CLAUSE.


All local laws, order, rules and regulations and ordinances which are inconsistent with the provisions of this ordinance are hereby repealed and modified accordingly.


SECTION 8. EFFECTIVITY. This ordinance shall take effect upon its approval.






