RESOLUTION NO. 6

(ORDINANCE NO. 2)

AN ORDINANCE COMPELLING AND OBLIGING ANY OWNER, OR OWNERS, ANY PERSON OR PERSONS, MANAGER OF ANY COMPANY, CORPORATION AND/OR ASSOCIATION RESIDING AT POBLACION OR WITHIN THE BARRIO OF BULALACAO, ORIENTAL MINDORO TO PROVIDE AND SUSTAIN WITH LOCAL FIRE APPARATUS AND/OR EXTINGUISHER SUCH AS: LADDER: AXE: ROPES TWO BUCKETS WITH WATER AND ETC., PREPARATORY TO MEET ANY INCIDENT FOR A HOUSE OR HOUSES TO BE RAZED OR BURNED WITH FIRE:

Be it ordained by the Municipal Council of Bulalacao,

That:-

Section 1.- For each every owner or owners of any house or houses within the Poblacion and throughout all barrios within this Municipality, Bulalacao, Oriental Mindoro, is or are obliged, compelled to provide with local equipments of fire apparatus such as: ladder; axe; ropes; buckets with water (two) in every house or houses preparatory to meet any incident to ~~be~~ happen in any house or houses to be razed or burned with fire, especially during hot season when houses is or are roofed with combustible materials such as cogon, nipa and buri and etc.,;

Section 2.- The purpose and scope of this Ordinance is to prepare and help those owners or owners of the houses to provide local equipments for suppressing and extinguishing any incident that may be occurred during the razing and burning of fire to any house or houses that may be happened;


SECTION 3.- PENALTY:- any owner or owners, manager of any association, partnership and/or corporation having not to meet and fulfill to provide the necessary requirements as herein stipulated in the provisions of this Ordinance shall upon conviction for its offense be punished by a fine of not less than five pesos (P5.00) and not more than fifteen pesos (P15.00) or imprisonment of not less than five days (5) and not more than fifteen days (15) or both such fine and imprisonment in the discretion of the court.


Section 4.- EFFECTIVITY: This Ordinance shall take effect after ten days of its passage.


