The calling of the Roll was performed by the Recorder with the members answering present when their respective names were called.

Likewise, the Recorder was also instructed to write the INP Station Commander and the Coast Guard Detachment to contact the captains or owners of Bangs who are catching fish within the territorial waters of this town without Mayor's Permit or License.

ORDINANCE NO. 12 ✓

ORDINANCE N

REQUIRING PERSONS, ASSOCIATIONS, COMPANIES AND CORPORATIONS TO DEPOSIT ₱200.00
TO THE MUNICIPAL TREASURER OF BULALACAO, ORIENTAL MINDORO BEFORE ERECTING FISH
CORALS WITHIN THE MUNICIPAL WATERS OF THIS TOWN ON THE FOLLOWING GROUNDS TO WIT.

WHEREAS, there are Fish corals being erected within the Municipal waters
of Bulalacao, Oriental Mindoro;

WHEREAS, if these fish corals are no longer usable, the owners of which
just leave them without pulling the bamboo post which endanger not the small
bancas but also motor boats specially during night;

WHEREAS, in order to avoid accident of the above allegations, the Sang-
guniang Bayan hereby Ordains, that:

Section 1.- All persons, companies, associations and corporations are here-
by required to deposit ₱200.00 in the Municipal Treasurers Office before erecting
Fish corals within the Territorial waters of Bulalacao, Oriental Mindoro;

Section 2.- The amount of ₱200.00 aforementioned, shall be given back to the
owner on condition that he will pull out all the bamboo post if his fish coral
is no longer usable to avoid danger or accident to small bancas and motor boats.
If he fails to do so, said amount will be forfeited by the Municipal government
and will be paid for the labor of those who will pullout the bamboo post or clear
the area within the fish coral is being erected;

Section 3.- Violation of this Ordinance or parts thereof shall be fined
the amount of ₱50.00 to ₱200.00 or an imprisonment of 10 days to 30 days or both
such fine and imprisonment at the discretion of the court;

Section 4.- Ordinances or Ordinances inconsistent with the provisions of this
Ordinance are hereby repealed or modified accordingly.

Section 5.- This Ordinance shall take effect immediately upon its approval.

UNANIMOUSLY APPROVED.

THERE HAVING no other business to be transacted so on motion of Hon. Perpetuo C. Canges, seconded by Hon. Amparo S. Gregorio, the meeting was adjourned at 12:00 in the morning.
