THE RELEASE OF THE FOREST AREAS IN THE MUNICIPALITY OF BULALAGAO, ORIENTAL  
MINDORO FOR AGRICULTURAL PURPOSES

WHEREAS, the municipality of Bulalacao, Oriental Mindoro has a wide Forest  
Lands and suited for agricultural purposes;

WHEREAS, immediate repair of this Irrigation project is of vital importance;

NOW, THEREFORE, resolved as it is hereby resolved to request Engineer Crisanto Madraso, Chief Provincial Irrigation Engineer, NIA, Calapan, Oriental Mindoro, the immediate repair of Cabilian Commonal Irrigation Project (CCIP) to facilitate the need of farmers;

RESOLVED, FURTHER, that copies of this resolution be furnished, Engineer, Crisanto Madraso, Chief Provincial Engineer, NIA, Calapan, Oriental Mindoro and the National Irrigation Administration, Pila, Laguna for their information and appropriate action....
