RESOLUTION NO. 50

REQUESTING DEPUTY MINISTER ROLLEO IGNACIO, MINISTRY OF NATURAL RESOURCES AND CONCURRENTLY DIRECTOR OF LANDS, QUEZON CITY FOR PROPER CONSIDERATION AND ACTION TO THE RESOLUTION NO. 13 OF THE SANGGUNIANG BAYAN OF BULALACAO, ORIENTAL MINDORO, DATED MARCH 2, 1981 AND RESOLUTION NO. 4, OF THE BARANGAY OF CAMBUNANG, DATED JULY 9, 1982

WHEREAS, Resolution No. 13 of Sangguniang Bayan of Bulalacao, dated March 2, 1981 and Resolution No. 4 of Sangguniang Barangay of Cambunang, dated July, 1982 were sent to the Director Lands, Quezon City for consideration;

WHEREAS, these Resolutions is in connection of the claim of the Municipal Government on the Commonwealth Lot located in Barangay Cambunang for barangay site and school site purposes;

WHEREAS, on July 17, 1985 the office of the District land officer stationed at Roxas, Oriental Mindoro conducted an ocular inspection and investigation of the Commonwealth lot;

WHEREAS, the result of this ocular inspection and investigation, attached hereto was forwarded to the former Director of lands, thru the District land officer, San Mariano, Oriental Mindoro, but until now no action was taken thereof;

NOW, THEREFORE, resolved as it is hereby resolved to request Deputy Minister Rolleo Ignacio, Ministry of Natural Resources and concurrently Director of Lands, for proper action on the commonwealth lot, situated at Barangay Cambunang for school site and barangay site purposes;

RESOLVED, FURTHER, that copies of this resolution be furnished, Deputy Minister Rolleo Ignacio, Ministry of Natural Resources and concurrently Director of lands, the Minister of Natural Resources, Quezon City, for consideration and appropriate action, the District land officer, San Mariano, Oriental Mindoro and Governor Benjamin (Chippy) Espiritu for their information and reference;
