REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO, MALACANANG, MANILA THE LIFTING OF BAN ON THE SLAUGHTERING OF CARABAOS AS PROVIDED FOR IN EXECUTIVE ORDER NO. 626-A

WHEREAS, pursuant to Executive Order No. 626 of the former President of the Republic of the Philippines, slaughtering of carabaos regardless of old age fit and physically unfit to work is strictly prohibited;

WHEREAS, despite of this Order violators still manage to circumvent the prohibition against inter-provincial movement of carabaos by transporting them to other places for market;

WHEREAS, if Ban of slaughtering carabaos be lifted, farmers could sell carabaos with good price and buyers will not resort to illegal practices by giving money considerations to law enforcers thus encouraging corruption in the government and rampant thievery;

WHEREAS, lifting the ban on the slaughtering of carabaos will not only benefit farmers but will also raise the revenue of the Municipal Treasury;

NOW, THEREFORE, on motion of Hon. Angelico Lignes, duly seconded by Hon. Wilfredo Alejandro, be it;

RESOLVED, as it is hereby resolved to request Her Excellency President Corazon C. Aquino, Malacanang Manila, the lifting of Ban on the slaughtering of Carabaos regardless of age unfit or physically unfit to work;
