RESOLUTION NO. 30 ✓

REQUESTING HER EXCELLENCY PRESIDENT CORAZON C. AQUINO, MALACANANG, MANILA THE RETENTION OF THE COAL MINE OPERATION OF FF CRUZ & CO. AT BARANGAY GAMBUNANG, BULALACAO, ORIENTAL MINDORO

WHEREAS, the Minorities from the different towns of Oriental Mindoro stage a rally on June 21, 1986 at the Camp site of FF Cruz & Co, at Barangay Cambunang, this municipality;

WHEREAS, the main objective of the rally is to stop the Coal mine operation of FF Cruz & Co, and vacate the premises because the minorities claimed that the land belong to their Forefathers;

WHEREAS, the people of Bulalacao thru: the Sangguniang Bayan strongly opposed to the move of the ralliest on the following grounds, to wit:

- a) That if the Coal mine operation will be stopped many families whose income depends only to the Company will starve;
 - b) That unemployment and criminality will surely increase and will be a problem of the government;
 - c) That FF Cruz & Co. is the only hope of people for the development of the town of Bulalacao because the proposed Warf will be constructed near the town and electric lights will be installed passing the town proper;
 - d) That economy will not only affect the town of Bulalacao but also the whole Archepilago of the Philippines because Coal serves as fuel and other purposes;
 - e. That the little town of Bulalacao is located in the Southernmost of the Province of Oriental Mindoro and far behind from countryside development; that someday and shomeshow Bulalacao might be like that of the Island of Simerara, Caluya, Antique which has good roads and well lighted and Airport has been constructed because of Coal mine operation;

WHEREAS, the area of operation of FF Cruz & Co, does not affect the lands of the minorities because their lands are located in the upper mountains of Sitio Umabang, Banaba and barangay Benli, this municipality while the Coal mine operation is on the base of the mountain of Barangay Cambunang some 5 to 6 kilometers away from the these sitios mentioned above;
