The Sangguniang Bayan of Bulalacao, on motion of Hon. Francisco J. Pandino, seconded by Hon. Vice Mayor Ludovico C. Silang, RESOLVED, to approve the following Ordinance:

ORDINANCE

ORDINANCE NO. 2

AN ORDINANCE AMENDING RESOLUTION NO. 23, ORDINANCE NO. 7, SERIES OF 1979 BY INCREASING THE RATE OF ANCHORAGE FEE TO ALL MOTOR BANCA FROM ₱1.00 TO ₱3.00 PER ANCHORE ALONG THE SHORELINES OF BULALACAO, ORIENTAL MINDORO

SECTION 1. Anchoarge fee is hereby imposed to owners of all motor banca coming and anchoring in the shorelines of the town of Bulalacao, Oriental Mindoro;

SECTION 2. Owners of all motor banca coming and anchoring along the shorelines of the town of Bulalaca shall pay the amount of ₱3.00 as anchorage fee;

SECTION 3. Official receipt or cash tickets shall be issued to owners of motor banca or to persons incharge of carryig same by the Municipal Treasurer of his authorize representatives;

SECTION 4. Violation of this Ordinance or parts hereof shall be punished by a fine of ₱50.00 to ₱ 200.00 or imprisonment of 10 days to 30 days or both such fine and imprisonment at the discretion of the court;

SECTION 5. Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 6. This Ordinance shall take effect twm (10) days after its passage;

RESOLVED, FURTHER, that copies of this Ordinance be furnished, the Provincial Treasurer, Calapan, Oriental Mindoro for review and approval;
