WHEREAS, there are indigent sick people in this municipality who cannot afford to go to Roxas General Hospital for treatment;

WHEREAS, this sick people, because of poverty died without consulting a doctor;

WHEREAS, the PC Provincial Commander in his visit to this town recently, made a verbal promise with Municipal officials that they will assign Military Physicians to render free service on condition that they Municipal government of Bulalacao will provide medicine;

WHEREAS, the Municipal government of Bulalacao has a meager income hence, cannot afford to purchase medicines for emergency purposes;

NOW, THEREFORE, resolved, as it is hereby resolved to request the Provincial Health officer, Calapan, Oriental Mindoro for additional supply of medicines for the use of Military Doctors who will render free service in the municipality of Bulalacao, Oriental Mindoro;

RESOLVED, FURTHER, that copies of this resolution be furnished, the Provincial Health Officer, Calapan, Oriental Mindoro, for consideration and appropriate action.
