RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR TO PURCHASE ONE (1) UNIT OF SERVICE VEHICLE
FOR THE USE OF THE SANGGUNIANG BAYAN, THIS MUNICIPALITY IN THE MONITORING OF VARIOUS
DEVELOPMENT PROJECTS AND IN THE CONDUCT OF REGULAR CONSULTATION WITH THE PEOPLE

" WHEREAS, the absence of sufficient number of vehicles is such a problem that
affects all sectors of the Municipality of Bulalacao, Oriental Mindoro;

" WHEREAS, the fact that there is no public transportation that is plying to com-
munitary barangays, hinders our government officials from reaching their constituents;

" WHEREAS, establishing a rapport and bringing the government closer to the people
are vital if we are to encourage more active partnership and strong cooperation between
the government and the citizenry;

" WHEREAS, our councilors are tasked with monitoring the development projects on
areas covered by their assigned barangays;

" WHEREAS, the amount of Three Hundred Thousand Pesos (P300,000.00) is already
appropriated for this purpose, under the Revised Annual Budget for Calendar Year 1993;

NOW THEREFORE:

BE IT RESOLVED AS IT HEREBY RESOLVED to authorize the Municipal Mayor to purchase
one (1) unit of service vehicle for the use of the Sangguniang Bayan, this Municipality
in the monitoring of development projects and in the conduct of regular consultation
with the people;

RESOLVED FURTHER, to submit copies of this Resolution to Hon. Luis C. Liwanag II,
Deputy Executive Secretary, Office of the President, Malacanang, Manila, for his infor-
mation and kindest approval.
