RESOLUTION NO. 66

REQUESTING THE PROVINCIAL AGRICULTURAL OFFICER, DEPARTMENT OF AGRICULTURE
CALAPAN, ORIENTAL MINDORO TO HOLD ALL FISH DEALERS FROM THIS MUNICIPALITIES
WHO DO NOT HAVE LICENSE AS DEALER AND PERMIT TO TRANSPORT FISH TO MALABON
METRO MANILA VIA CALAPAN PIER.

WHEREAS, Only few fish dealers in the Municipality of Bulalacao had
secured license and permit to transport fish;

WHEREAS, it has been observed that fish dealers who do not have li-
cense or permit to transport continued to delivered fish to Malabon VIA
Calapan pier without securing the necessary papers from the Municipal
Government of this town.

WHEREAS, the Municipal Government is incurring great loss over
draft when it comes to collection of taxes on fishery because of negligence
of those concern to pay taxes willingly;

NOW, THEREFORE, On motion of Hon, Nenito S. Ambong duly seconded by
Hon. Panganiban Mayot, be it;

RESOLVED, as it is hereby resolved to request the Provincial Agri -
cultural Officer, Department of Agriculture Calapan, Oriental Mindoro to
hold fish being delivered to Malabon VIA Calapan Pier without necessary
license of the owner as fish dealer nor permit to transport issued by
the Municipal Government of Bulalacao;

RESOLVED FURTHER, that a copy of this resolution be furnished, the
Provincial Fishery Office, Calapan Oriental Mindoro for consideration
and proper action.


