RESOLUTION REQUESTING THE HONORABLE RAUL S. ROCO, SENATE OF THE REPUBLIC OF THE PHILIPPINES, MANILA TO EXTEND ASSISTANCE IN THE CONCRETING OF PANTILLO STREET, POBLACION, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Bulalacao, the farthest and southermost municipality in the province of Oriental Mindoro, is a potential tourist destination of the 90's due to its numerous exotic islands with stretches of powdery white sand beaches and clear, unpolluted water;

"WHEREAS, this Municipality, although endowed with rich, natural and beautiful sceneries, gets no significant advancement in terms of infrastructure development, some of its streets are still unconcreted and becomes muddy comes rainy season;

"WHEREAS, municipal streets, aside from being used everyday by thousands of pedestrians and vehicles, are traditionally regarded as yardsticks of town's economic status;
