REQUESTING THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICER, DENR, SAN MARIANO, ROXAS, ORIENTAL MINDORO TO PERMIT THE MUNICIPAL GOVERNMENT TO FELL THE TREES DONATED BY MR. Ricardo T. SALAS, TO BE USED IN THE CONSTRUCTION OF BRIDGE AT BARANGAY MAUJAO, BULALACAO, ORIENTAL MINDORO

"WHEREAS, there exists a dire need to immediately repair the road connecting Poblacion to Milagrosa in order facilitate the movement of goods and people of these place and other adjacent barangays;

"WHEREAS, a particular bridge at Sitio Lambok, Barangay Maujao was destroyed by the onslaught of series of typhoons;

"WHEREAS, this bridge is a very vital connection, without it Sitio Lambok and Barangay Milagrosa would not be reached by vehicles;

"WHEREAS, the immediate repair of this bridge will redound to the economic and social benefits of the people living therein; Now; therefore, be it

RESOLVED, AS IT IS HEREBY RESOLVED, To request the Community Environment and Natural Resources Officer, DENR, San Mariano, Roxas, Oriental Mindoro to permit the Municipal Government to fell the trees donated by Mr. Ricardo T. Salas, to be used in the construction of bridge at Barangay Maujao, Bulalacao, Oriental Mindoro;
