REQUESTING POLICE SUPERINTENDENT ROMEO ADDURRO, PNP PROVINCIAL DIRECTOR TO AUGMENT POLICE OFFICERS AT THE PNP BULALACAO STATION, BULALACAO, ORIENTAL MINDORO

"WHEREAS, Section 27 of Republic Act No. 6975 otherwise known as the Department of Interior and Local Government Act of 1990 provides a manning level of the PNP to be approximately in accordance with a police-to-population ratio of one (1) policemen for every five hundred (500) persons;

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro has a population of more or less Twenty Five Thousand (25,000) people while its total police force at present is no more than fifteen (15) personnels;

"WHEREAS, considering the bad state of peace and order at this Municipality, population density and actual demand of the service, the need to augment the strength is absolutely necessary;

"WHEREAS, being the farthest and southernmost part of the Province of Oriental Mindoro, the PNP Bulalacao Station could hardly reach the Provincial Headquarter for assistance in times of insurgencies due to the absence of a good transportation and communication systems, thus, a sufficient and fully-armed personnels at this Station are direly needed; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request Police Superintendent Romeo Addurro, PNP Provincial Director to augment police officers at the PNP Bulalacao Station, Bulalacao, Oriental Mindoro;
