REQUESTING CONGRESSMAN JESUS M. PUNZALAN TO ADEQUATE THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) FOR THE REHABILITATION OF BALATASAN ELEMENTARY SCHOOL, BULALACAO, ORIENTAL MINDORO

"WHEREAS, education is essential to the nation building ^{has} already acknowledge Article II by the Declaration of State Policies of the 1987 Constitution; and further, it mandates that basic education be made accessible to all Filipinos;

"WHEREAS, it is perplexing and disturbing that our nation is of a long way from spreading the benefits of basic education to the great majority of the countrymen, especially those in far-of rural areas, as contained in the Report submitted by the Congressional Commission on Education (EDCOM) in 1991 on account of lack of teachers and school buildings in these areas;

"WHEREAS, some buildings in Balatasan Elementary School are already dilapidated, needing immediate repair and rehabilitation to make it more serviceable to the benefit of the public;

"WHEREAS, such repair/rehabilitation shall need financial allocation from the Government which the Municipality can hardly provide; Now, therefore, be it

rehabilitation of Balatasan Elementary School, Bulalacao, Oriental Mindoro;


