" RESOLUTION NO. 97-04-077

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY  
1997 OF BARANGAY MAASIN, BULALACAO, ORIENTAL MINDORO APPRO-  
PRIATING THE AMOUNT OF THREE HUNDRED THREE THOUSAND FOUR  
HUNDRED FORTY SIX PESOS AND FIFTY SIX CENTAVOS (P303,446.56)  
PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE  
NO. 97-01, DATED MARCH 3, 1997

"WHEREAS, Section 57 and Section 447 par (1i) empow-  
er the sangguniang bayan to review all ordinances passed  
by the sangguniang barangay to determine whether these  
are within the scope of the prescribed powers of the sang-  
gunian and not to be inconsistent with law or municipal  
ordinance;

"WHEREAS, the Sangguniang Barangay of Maasin, Bulala-  
cao, Oriental Mindoro submitted its Barangay Fund Annual  
Budget for FY 1997 showing therein the sources of income  
and the barangay expenditures starting January 1, 1997  
up to December 31, 1997;

"WHEREAS, the Barangay Fund Annual Budget for FY  
1997 of Barangay Maasin was duly taken up by the Sanggu-  
niang Bayan of Bulalacao, Oriental Mindoro in the regular  
session held on April 28, 1997 with the following recommen-  
dations:

- i. The program and projects under the 20% De-  
velopment Fund should be in accordance with  
Memorandum Circular No. 96-263 entitled

'Policies and Guidelines on the Utilities of the Twenty Percent (20%) Development Fund and Related Matters;










- ii. That the 20% of the 20% Development Fund should be utilized to finance programs that address to Human and Ecological Security (HES);




