REQUESTING DR. BENJAMIN CRUZ, DIVISION SCHOOL SUPERINTENDENT, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS TO OPEN UP GRADE 1 CLASS AT SITIO YUNOT, BARANGAY BAGONG SIKAT, BULALACAO, ORIENTAL MINDORO

"WHEREAS, education is essential to nation building as acknowledged by Section 17, Article 11 in the Declaration of State Policies of the 1987 Constitution;

"WHEREAS, it is mandated that basic education be made accessible to all Filipinos;

"WHEREAS, it is perplexing and disturbing, however, that we are long way from spreading the benefits of basic education to the great majority of our countrymen, especially those in far-off rural areas as reported by the Congressional Commission on Education (EDCOM) in 1991;

"WHEREAS, as an example, many children who are of school age at Sitio Yunot, Barangay Bagong Sikat, this Municipality, have to walk several kilometers in order to get elementary education;

"WHEREAS, the opening -up of Grade 1 class in Sitio Yunot shall redound to the socio-economic benefits of the residents therein; Now, therefore, be it

RESOLVED, AS IT IS HEREBY RESOLVED, To: Request Dr. Benjamin Cruz, School Division Superintendent, Department of Education, Culture and Sports, Calapan, Oriental Mindoro to open-up Grade 1 class at Sitio Yunot, Barangay Bagong Sikat, Bulalacao, Oriental Mindoro;
