"RESOLUTION NO. 97 - 02 - 026

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 1997 OF BARANGAY SAN FRANCISCO BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF TWO HUNDRED SEVENTY TWO THOUSAND SEVEN HUNDRED FIFTY SEVEN PESOS AND EIGHT CENTAVOS (P272,757.08) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1 DATED JANUARY 15, 1997

"WHEREAS, Section 57 and Section 447 par (1i) empower the sangguniang bayan to review all ordinances passed by the sangguniang barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinances;

"WHEREAS, the Sangguniang Barangay of San Francisco, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for Fiscal Year 1997 showing therein the sources of income and the barangay expenditures starting January 1, 1997 up to December 31, 1997;

"WHEREAS, the Barangay Fund Annual Budget for FY 1997 of Barangay San Francisco was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on February 24, 1997 with the following recommendations:

- i. The programs and projects under the 20% Development Fund shall be in accordance with Memorandum Circular No. 96-263 entitled "Policies and Guidelines on the Utilization of the Twenty Percent (20%) Development Fund and Related Matters;

- ii. That the 20% of the 20% Development Fund should be utilized to finance programs that address Human and Ecological Security (HES);
- iii. The disbursements of appropriation shall be guided by existing COA rules and regulations;

Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 1997 of Barangay San Francisco, Bulalacao, Oriental Mindoro appropriating the amount of Two Hundred Seventy Two Thousand Seven Hundred Fifty Seven Pesos and Eight Centavos (P272,757.08) passed under Sangguniang Barangay Appropriation Ordinance No. 1, dated January 15, 1997 subject to compliance with all existing laws, rules and regulations;
