" RESOLUTION NO. 97-01-018

IMPOSING A SIXTY (60) DAY SUSPENSION AGAINST HONORABLE ELMO M. BACULINAO, MEMBER OF THIS SANGGUNIANG BAYAN, FOR VIOLATING THE LATTER'S INTERNAL RULES AND PROCEDURE

"WHEREAS, Honorable Elmo M. Baculinao according to the record committed four (4) consecutive absences during the regular sessions of this sanggunian held on January 6, 13, 20 and 27, 1997;

"WHEREAS, such absences of Hon. Baculinao, considering that they are without justifiable cause, constitute violation of Section 1 Rule XVII of Special Ordinance No. 93-01 otherwise known as Internal Rules and Procedure of Sangguniang Bayan of Bulalacao, Oriental Mindoro which provides as follows:

'this Sanggunian may punish its members for disorderly behaviour and for absences without justifiable cause for four (4) consecutive sessions by censure, reprimand, exclusion from the session suspension for not more than sixty (60) days or by expulsion. Provided that the penalty of suspension or expulsion shall require the concurrence of two-thirds (2/3) of all its members. Provided, further that a member convicted by final judgments to imprisonment of at least one (1) year for any crime involving moral turpitude shall be automatically expelled from this sanggunian';

"WHEREAS, after careful, thorough and painstaking assessment and evaluation of the evidence available, both documentary and testimonial, this Sangguniang Bayan found Honorable Elmo M. Baculinao guilty of absenteeism within the meaning of Section 1 Rule XVII of the Internal Rules and Pro-

cedure; Now, therefore, be it

RESOLVED, AS IT IS HEREBY RESOLVED, To: Impose a sixty (60) day suspension against Honorable Elmo M. Baculinao, Member of this Sangguniang Bayan for violating the Internal Rules and Procedure, recognizing the actual and potential damage inflicted on the dignity, integrity and reputation of the Sangguniang Bayan and its members individually and collectively;


RESOLVED, FURTHER, to forfeit the salaries, emoluments and all other allowances of Honorable Elmo M. Baculinao in favor of the Municipal Government for the period covering his suspension;


RESOLVED, FURTHERMORE, that the suspension herein imposed against Honorable Elmo M. Baculinao shall take effect on the 1st day of February 1997 and shall last until April 1, 1997;

RESOLVED, FINALLY, to let copies of this resolution be furnished the Provincial Governor, Honorable Rodolfo G. Valencia, Capitol Complex, Calapan, Oriental Mindoro, the Municipal Mayor, Hon. Gemma G. Salas, the Municipal Treasurer, Mr. Nachor S. Cabagay, the Municipal Local Government Operation Officer, Mr. Melencio Faminialagao and Honorable Elmo M. Baculinao, all of Bulalacao, Oriental Mindoro for their information, guidance and ready reference;
