“WHEREAS, water plays a vital role in sustaining man’s life and in preserving their good health by decreasing potential diseases that might be brought about by the lack of potable water;



“WHEREAS, there is a spring at the abovementioned place ready to be developed into a water system that would best served the constituents; Now, therefore, be it


