EARNESTLY REQUESTING THE HONORABLE MANUEL G. ANDAYA, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO GRANT THE AMOUNT OF SIXTY THOUSAND PESOS (P60,000.00) TO BE USED FOR THE COMPLETION OF ONE (1) CLASSROOM BUILDING AT NASUCOB ELEMENTARY SCHOOL, BARANGAY NASUCOB, BULALACAO, THIS PROVINCE

"WHEREAS, Section 13, Article II of the Philippine Constitution provides that the State recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being. It shall inculcate in the youth patriotism and nationalism and encourage their involvement in public and civic affairs;

"WHEREAS, Nasucob Elementary School at Barangay Nasucob was able to start the construction of one classroom building in 1999 through fund raising projects and personal contributions of the Parents Teachers and Community Association or PTCA however, appeared to be insufficient to complete its construction;


"WHEREAS, such initiative of constructing additional classroom building at the abovementioned school was made in order to provide additional learning facilities and accommodate the increasing enrollees thereat;

"WHEREAS, an approximate amount of Sixty Thousand Pesos (P60,000.00) is needed to complete the construction of one classroom building at Nasucob Elementary School which this Body believes that the good congressman is more than willing to help if only for the benefits of the pupils; Now, therefore, be it


