
"WHEREAS, seeing the socio-economic benefits that would emanate from the functional circumferential road, it is very important if the same road be made passable even during rainy season;


"WHEREAS, the immediate completion of Bulalacao to San Jose Circumferential Road would only be realized through the interference of the good congressman; Now, therefore, be it


