RESOLUTION NO. 03-09-138-A

REQUESTING THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) THRU THE BUREAU OF FIRE PROTECTION TO ALLOCATE THE AMOUNT OF THREE HUNDRED THOUSAND PESOS (Php300,000.00) TO BE USED AS FREIGHT COST FOR THE TRANSPORT OF A DONATED ONE (1) UNIT OF FIRE TRUCK IN FAVOR OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO BY THE PHILANTHROPIC ORGANIZATION OF MINDOREÑOS IN THE UNITED STATES

WHEREAS, it is a Constitutional mandate that the State shall ensure the security and protection of its people against the damage of lives and properties brought about by either natural or man-made calamities;

WHEREAS, one of the most dangerous calamities that human beings may suffer is the incidence of fire resulting from countless reasons either by negligence or by accident;

WHEREAS, taking into consideration, the sufferings, agony, misfortune and emptiness resulting from this calamity, the Municipal Government of Bulalacao needs to protect its constituents from the anguish emanating from the occurrence of fire by taking precautionary measures, sufficient knowledge and available equipment such that of a fire truck to control if not totally eradicate it;


WHEREAS, the availability of a fire truck during the occurrence of fire is indispensable in an effort to protect lives and properties; however, due to limited funds, this Municipality's prayer was fortunately answered by the philanthropic decision made by Filipino Community, particularly those of Mindoreños to donate one unit of fire truck to answer the aforementioned whose only consideration is for the beneficiary to put the bill of the freight cost;


WHEREAS, considering the limited financial capacity of this pro-Poor Municipality, it could not possibly fund such freight cost amounting to the tune of Three Hundred Thousand Pesos (Php300,000.00) and awash with the joy that we will no longer be constantly thinking of the multifarious negative effects of the dangers of fire, we are humbly request the DILG through the Bureau of the Fire Protection, that it be given the kindest of consideration and understanding; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED: To: Request the Department of Interior and Local Government (DILG) through the Bureau of Fire Protection to allocate the amount of Three Hundred Thousand Pesos (Php300,000.00) to be used as freight cost for the transport of a donated one unit of fire truck in favor of the Municipality of Bulalacao, Province of Oriental Mindoro by the philanthropic organization of Mindoreños in the United States;


ON JOINT MOTION of Councilors Eduardo C. Aceron and Juan L. Salas, Sr., duly seconded by all members present, foregoing was . . .


