
“WHEREAS, Madame Susan Umali during her visit here last June town fiesta pledged an additional amount to be used for the completion of the long-awaited project;


“WHEREAS, this noble act of congressman Umali and his wife will be much valued and long remembered by the beneficiaries; Now, therefore, be it


