REQUESTING DIRECTOR MALCOLM SARMIENTO, BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) TO GRANT ONE (1) UNIT OF PATROL BOAT FOR THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, distortion and disturbance of marine life brought about by various illegal fishing activities have resulted to the vanishing of flora and fauna, destruction of corals and other aquatic life leading to a critical reduction in marine resource productivity to the detriment of the marginal fishfolks whose living comes from fishing;

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro organized the fisheries and Aquatic Resource Management Council (FARMC) and Bantay Dagat tasked to monitor, implement fishery laws and ordinances and apprehend violators in an effort to protect and conserve marine life resources;


"WHEREAS, it is sadly observed that the FARMC and the Bantay Dagat could not readily discharge their duties and functions due to lack of support facilities such as that of a motorboat;


"WHEREAS, the Municipality of Bulalacao is hounded with financial constraints that the acquisition of a motorboat is believed to be realized only through the assistance of BFAR; Now, therefore, be it
