
"WHEREAS, pursuant to Section 43 par (a) of Republic Act No. 6975 otherwise known as the Department of Interior and Local Government Act of 1990, there shall be created by the Sangguniang Bayan in every municipality at least one (1) People's Law Enforcement Board (PLEB) which shall have jurisdiction to hear and decide citizens complaints or cases filed before it against erring officer and members of the Philippine National Police (PNP) where the Sanggunian concerned shall have representative on its composition,


"WHEREAS, customarily, this Sanggunian chooses the Chairman of the Committee on Peace and Order and Public Safety as its representative to PLEB, Incidentally Councilor Guillermo G. Salas, Jr holds such Committee; Now, therefore, be it


