RESOLUTION NO. 05-08-109

AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO CONTRACT WITH ENGR. RODOLFO V. DAYANGHIRANG OF THE DAYANGHIRANG SURVEYING AND DEVELOPMENT OFFICE FOR THE SURVEYING AND DOCUMENTATION OF GAWAD KALINGA SITES SITUATED AT BARANGAYS CAMBUNANG, MAUJAO AND BALATASAN, ALL OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AND RATIFYING THE SAME CONTRACT

"WHEREAS, the Municipality of Bulalacao, Oriental Mindoro was grateful for having three donees of the parcel of lands to be used as sites for the Gawad Kalinga Housing Projects at Barangay Cambunang donated by Engr. Rodolfo V. Dayanghirang, at Barangay Maujao donated by SB Member Rosalinda M. Cabagay and at Barangay Balatasan donated by Engr. Manuel G. Andaya;

"WHEREAS, these parcel of lands intended for Gawad Kalinga Housing Projects need to be surveyed for proper documentation in favor of the Municipality of Bulalacao which shall likewise be distributed to qualified beneficiaries under certain terms and condition as may be prescribed by the Local Government Unit;

"WHEREAS, the Municipality of Bulalacao allocated the amount of Forty Six Thousand Four Hundred Thirty Eight Pesos and Eighty Eight Centavos (Php46,438.88) as payment for the surveying and documentation of the abovementioned lands; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Dayanghirang of the Dayanghirang Surveying and Development Office for the Cambunang, Maujao and Balatasan, all of the Municipality of Bulalacao, Province of Oriental Mindoro and ratifying the same contract;


