RESOLUTION NO. 05-08-108-A

EARNESTLY REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO PRIORITIZED THE CONCRETING OF ROAD FROM SITIO LAMBOK, MAUJAO TO BULALACAO NATIONAL HIGH SCHOOL MAUJAO EXTENSION, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO

"WHEREAS, under Section 17 of Republic Act 7160 local government units are empowered to exercise powers and discharge such other functions and responsibilities such as those necessary, appropriate or incidental to an efficient and effective provision of the basic services and facilities such as that of construction and maintenance intended primarily to service the needs of the residents of the local government units concerned such as municipal roads, bridges and others;

"WHEREAS, under Section 25 of the same law, it is understood that the Office of the President may upon request of Local Government Unit concerned direct the appropriate National Agency to provide financial, technical or other forms of assistance to the Local Government Unit; and such assistance shall be extended at no extra cost to the Local Government Unit concerned, as further provided by the same law;

"WHEREAS, there is an established secondary school (an extension of the Bulalacao National High School) situated at Maujao which is an interior area of the barangay and wanting of an effective and efficient barangay road;

"WHEREAS, the only available road that could be traversed is that from Sitio Lambok and evidently students and faculties suffered the mud during the rainy season and thus hampering their studies in the pursuit of education and a better future;


