**RESOLUTION NO. 11-04-071**

REQUESTING THE LAND TRANSPORTATION FRANCHISING AND REGULATORY BOARD (LTFRB) FOR A COPY OF THE OFFICIAL FARE MATRIX FOR PROVINCIAL BUSES AND REQUIRING FURTHER FOR THE LIST OF THOSE WHO WERE GRANTED WITH FRANCHISE OR LINE ON THE ROUTE PLYING THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO SAN JOSE, OCCIDENTAL MINDORO AND VICE VERSA

**"WHEREAS,** the national highway connecting the Municipalities of Bulalacao, Oriental Mindoro and Magsaysay, Occidental Mindoro which virtually linked the two provinces was finally opened to traffic two years ago;

**"WHEREAS,** the amount of fare collected was not clear and purely dependent upon the discretion of the operators of public transport traversing thereat;

**"WHEREAS,** many of our commuters were complaining the exorbitant and excessive rate of fare collected from them particularly in the Bulalacao-San Jose route when compared to the fare matrix set by the LTFRB for all provincial buses;

**"WHEREAS,** in order to conform with law and to enforce a rational, equitable and legal fare to be collected, the LTFRB must provide the necessary fare matrix for the said route in order to serve as basis in the collection of fares;  
Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Land Transportation Franchising and Regulatory Board (LTFRB) for a copy of the official fare matrix for provincial buses and requiring further for the list of those who were granted with franchise or line on the route plying the Municipality of Bulalacao, Oriental Mindoro to San Jose, Occidental Mindoro and vice versa;


