EARNESTLY REQUESTING THE HONORABLE ROLANDO G. ANDAYA, JR., SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT THRU THE HONORABLE MARIO L. RELAMPAGOS, UNDERSECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT TO GRANT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO WITH ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP1.5M) WORTH OF MEDICINES FOR THE INDIGENT RESIDENTS OF THIS MUNICIPALITY

"WHEREAS, the Municipality of Bulalacao is located in the southernmost tip of the Province of Oriental Mindoro whose population is composed of approximately twenty percent hanunuo mangyan who does not have access to proper medical treatment and affordable medicines;

"WHEREAS, sufficient medicines added to the availability of medical equipments are necessary in an effort to maintain good health, prevention and control of diseases that save precious human lives;




"WHEREAS, faced with financial constraints, the above noble objective would only be realized through the benevolence of the Department of Budget and Management; Now, therefore, be it




