AQUINO, III, PRESIDENT, REPUBLIC OF THE PHILIPPINES THRU THE HONORABLE DINKY SOLIMAN, SECRETARY, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGARDING CERTAIN PROBLEM AREAS IN THE IMPLEMENTATION OF 4Ps IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the so-called Pantawid Pamilyang Pilipino Program (4P's) was conceptualized with the noble idea of helping those who are lesser in life among our fellow Filipinos by the government;
