**"WHEREAS,** pursuant to Republic Act. No. 7160 otherwise known as the Local Government Code of 1991, the local treasurer shall maintain depository in the name of their respective Local Government Unit with banks preferably government-owned located in or nearest to their respective areas of jurisdiction earning of its depository documents;

**"WHEREAS,** it is the pleasure of this Sanggunian to generate, protect and maximize the use of resources and revenues for the development of the Municipality and considering the proximity of the distance between the Municipality of Roxas to Bulalacao, this objective could easily be achieved as Roxas is only 45 kms. away compared to the present branch in Pinamalayan which is approximately 95 kms. In distance;
