RESOLUTION NO. 09 – 05 – 068

EARNESTLY REQUESTING THE SECRETARY, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) TO ALLOW THE LOCAL GOVERNMENT UNIT OF BULALACAO TO HAVE A CO-MANAGEMENT AGREEMENT WITH DENR IN UTILIZING THE PASTURE AREAS WITHIN THE MUNICIPALITY, PARTICULARLY THE PASTURE LANDS UNDER THE PASTURE LAND AGREEMENT ISSUED TO MADECO AND VARIOUS ISLETS NAMELY: BANGGASU, SILAD AND KARAMBINGAN

WHEREAS, Section 17, par ii of RA 7160, also known as the Local Government Code of 1991 provides that Local Government Units shall exercise pursuant to national policies and subject to supervision, control and review of the DENR implementation of community-based forestry projects which include integrated social forestry program and similar projects; management and control of communal forests with an area not exceeding fifty square kilometers; establishments of the parks, green-belts and similar forest development projects;


WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro cognizant of the need for coordinated efforts with DENR to achieve proper enforcement of natural resources conservation laws and regulations, and in the formulation and implementation of natural resource programs and projects submitted itself to work hand in hand with the DENR through the so-called co-management of the natural resources mentioned above which are found in the jurisdiction; for the promotion of welfare of the inhabitants living thereon; Now, therefore, be it


