RESOLUTION NO. 08-01-004

RESOLUTION GRANTING FRANCHISE TO MR. ANTHONY ENRIQUEZ FOR THE EXCLUSIVE RIGHTS TO ESTABLISH, OPERATE AND MAINTAIN COCKFIGHTING AT SITIO CAWACAT, BARANGAY CAMBUNANG, THIS MUNICIPALITY STARTING FROM JANUARY 1, 2008 UP TO DECEMBER 31, 2008

"WHEREAS, pursuant to Section 447 of Republic Act No. 7160, the Sangguniang Bayan is empowered to authorize and license the establishment, operation and maintenance of cockpits, regulate cockfighting and commercial breeding of gamecocks provided existing rights should not be prejudiced;


"WHEREAS, Mr. Anthony Enriquez is the only person who expressed his intention to operate and maintain cockfighting at the abovementioned place to which this Sanggunian deemed it right to grant him the necessary permit and license;

"WHEREAS, the grant of such permit shall be effective from January 1, 2008 up to December 31, 2008; Now, therefore, be it


RESOLVED AS IT IS HEREBY RESOLVED, To: Grant franchise to Mr. Anthony Enriquez for the exclusive rights to establish, operate and maintain cockfighting at Sitio Kawacat, Barangay Cambunang, this Municipality starting from January 1, 2008 up to December 31, 2008;


