EARNESTLY REQUESTING THE DEPARTMENT OF AGRICULTURE THROUGH SENIOR UNDERSECRETARY, HONORABLE DOMINGO F. PANGANIBAN TO PRIORITIZE THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO IN THE GRANT OF FINANCIAL GRANT/ASSISTANCE IN THE AMOUNT OF FIVE MILLION PESOS (PhP5M) TO BE USED FOR THE ACQUISITION OF THREE UNITS FARM TRACTORS UNDER THE ENHANCED "KADIWA NI ANI AT KITA INCLUSIVE FOOD SUPPLY CHAIN PROGRAM" OF THE DEPARTMENT OF AGRICULTURE

"WHEREAS, pursuant to the declaration of State of Emergency under Republic Act No. 11469 (Bayanihan Act of 2020), the Department of Agriculture (DA) among others has been tasked to ensure availability of food by adopting measures as may reasonably be necessary to facilitate and minimize disruption to the supply chain, especially for basic commodities and services to the maximum extent possible;

"WHEREAS, Memorandum Circular No. 16, series of 2020 established the Guidelines on Financial Grant Assistance to Farmers and Fisherfolk Cooperatives/Associations and Community Based Organizations under the Enhanced "Kadiwa ni Ani at Kita Inclusive Food Supply Chain Program" which seeks to ensure food commodities available and accessible in high consumer demand areas, particularly among the poor and low-income families by harnessing private sectors participation, capacity enhancement of farmers' cooperatives and associations and engaging community organizations' participation in food supply distribution system;

"WHEREAS, the Municipality of Bulalacao is vast agricultural land producing large volume of rice, corn, garlic and varieties of fruits and vegetables transported to nearby provinces and Metro Manila. It has 31 farmers cooperatives and associations accredited in the Sangguniang Bayan for partnership in an effort mutual support and assistance to achieve agricultural growth and sustainability;


"WHEREAS, growth in agriculture results in an almost immediate impact in terms of increased employment of rural labor in a host of non-tradable activities. Most farm households supplement their income from non-farming earnings thus having an immediate impact on poverty reduction and food security. Because of this, farming industry should be extended full support to improve production; **Now, therefore, be it...**


