**RESOLUTION TO FOLLOW-UP THE REQUEST OF THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO PRESIDENT RODRIGO ROA DUTERTE, REPUBLIC OF THE PHILIPPINES REGARDING THE IMMEDIATE DOWNLOADING OF THE EIGHTY MILLION PESOS [PhP80M] WORTH OF PROJECTS FROM NTF-ELCAC AND FURTHER REQUESTING THAT IMPLEMENTATION AND MANAGEMENT OF THESE PROJECTS BE DONE BY THE LOCAL GOVERNMENT UNIT OF BULALACAO**

**“WHEREAS**, Executive Order No. 70 signed in December, 2018 created the National Task Force to End Local Communist Armed Conflict [NTF-ELCAC] institutionalized a whole of nation approach in obtaining exclusive and sustainable peace giving as an effective solution against communist terrorists;

**“WHEREAS**, the Municipality of Bulalacao, Province of Oriental Mindoro is an advocate and beneficiary of KALAHI-CIDDS Program wherein during the conduct of monitoring, assessment and evaluation, identified Barangays Benli, Milagrosa, Nasucob and San Isidro as first beneficiaries of NTF-ELCAC funds;

**“WHEREAS**, the NTF-ELCAC appropriated the amount of PhP80M for its beneficiary such as the Municipality of Bulalacao. It is learned that such amount was already downloaded to the Provincial Government of Oriental Mindoro several months ago, however, implementation of projects to the four [4] identified barangays beneficiaries have not yet started up to this moment whereas, other municipality in Occidental Mindoro are now in the process of implementation;
